

Stowe Golf Club Terms and Conditions 2024

- 1. Course etiquette must always be observed.
- 2. Members are requested to observe the rules of dress code when playing the course. Jeans and Trousers tucked into socks are not acceptable. Golf shoes must be worn.
- 3. Each player should have one bag of clubs including a putter, a pitch repairer, and a ball marker.
 - Any player not complying with the above will be asked to leave the course.
- **4.** Anyone wishing to play on the course or in any of the fixtures listed must book a tee time on the Masterscoreboard booking site.
- **5.** During term time the Golf Course is available to members as follows:

- **6.** Monday mornings are allocated to Seniors for their competitions. A block of tee times will be reserved each Monday to accommodate this.
- 7. Tuesday is officially Ladies Day and Sunday mornings are allocated for a main club competition. A block of tee times will be reserved each Tuesday and Sunday morning to accommodate this.
- 8. Course Closure—The Golf Club and its members must be aware that the decision to close the golf course at any time rests entirely with Stowe School. A decision to close the course, generally for reasons of inclement weather, will usually be taken by 7.30am on the day. Notice of closure will be posted on the club Facebook page and the group WhatsApp and a notice will be placed at the entrance by the security cabin. For play on Christmas and New Years Day, the course will be inspected on the previous day and any decision to close will be notified by 12 noon on 24th December and 31 December respectively.



9. Green Fees

A green fee of £20 is charged for one round only (9 or 18 holes). Guests playing more than 18 holes should pay the applicable additional green fees.

Green fees must be booked and paid for via your Master Scoreboard log in. Please show a copy of your receipt to Security on arrival.

10. First Aid

In the event of First Aid being required on the golf course, the School Security cabin will provide initial support and must be contacted on 01280 818228/824140

11. Safeguarding

12. Site Rules

On arrival, please enter via the Security cabin, ensure your golf sticker is displayed on your vehicle windscreen to ensure easy access to the site.

Please adhere to the 15mph speed limit when driving onsite

13. The Club House

- a) The clubhouse shall be open to Members from 0700 to 2300, Monday to Sunday, with extensions only as authorised by the Committee
- b) Providing the Club has a Registration Certificate under the Licensing Act, the permitted bar hours shall be:-

Monday to Saturday 1100 to 2300

Sunday and Good Friday 1200 noon to 2230

Christmas Day 1200 noon to 1500

1900 to 2230

- c) The purchase and supply of intoxicating liquor stocks shall be the concern of nominated persons from the Committee.
- d) No alcohol is to be sold or supplied to persons under the age of 18.
- e) Sales of alcohol for consumption off the premises shall be restricted to Members only.



- f) On match days, sales of alcohol shall be to Members, playing opponents and officials only. Spectators and supporters must be signed in by a member as bona fide guests.
- g) Alcohol may be sold to persons attending the Club premises for social or other functions authorised by the Committee, including those School Staff who are Social Members of the Club. No function is to be held for which admission is by money on the day at the door.

14. Regulations

The Committee cannot hold itself responsible for any loss of Members' property by fire or theft or other cause whilst on or with Club premises.

Dogs shall not be permitted in the clubhouse or on the golf course.
